CDs available through our firm feature:

- Safety of principal: FDIC insured up to a maximum of \$250,000 aggregate principal and accrued interest per account ownership category per issuing bank.<sup>1</sup>
- **Diversification:** A large selection of issuers and maturities ranging from three months to 20 years.
- **Survivor's put option**<sup>2</sup>: In the event of the death of a CD holder, the decedent's estate may withdraw the CD from the bank at par plus accrued interest.
- 1 CDs at an issuing bank are insured by the FDIC, an independent agency of the US government, up to a maximum of \$250,000 (including principal and accrued interest) for all deposits held in the same insurable capacity (e.g., individual account, joint account, IRA, etc.) at the issuing bank. CD amounts are aggregated with other deposit accounts at the issuing bank held in the same insurable capacity. Total deposits (principal plus interest) that exceed the specified maximum are considered uninsured for the excess. Furthermore, CDs purchased at a premium (a price above par) are only FDIC insured up to par value. Any premium paid over par value is not FDIC insured.
